To Whom it May Concern:

We are responding to your inquiry concerning the authenticity of works attributed to the late Keith Haring. As a public service, the Keith Haring Studio, LLC is pleased to assist you in this inquiry free of charge for sculptures, drawings, paintings, and prints. Please note that mass-produced objects, signed ephemera (posters, autographs, clothing), and subway drawings will not be reviewed and we do not offer appraisals. Do NOT submit actual works of art unless the Keith Haring Studio, LLC specifically requests you to do so. We cannot accept authentication submissions or paperwork in person.

The Keith Haring Studio, LLC considers works submitted approximately four times a year, thus there may be a considerable lag between the time you submit your paperwork and the time you receive our response. Every submission will receive a letter of response. Please do not contact us to confirm that we have received your submission.

In order to have your work considered by the Keith Haring Studio, LLC, the Owner of the work must submit the following documentation and adhere to the parameters therein:

1. A signed and completed copy of the Certification, Release and Indemnity Agreement, for each work (enclosed herein). Please print clearly and complete all sections including provenance.
2. Clear color 4" x 5" Ektachrome transparencies of the work must be submitted of the work in its entirety with views of the front and back (even if blank). A detail of the signature or any inscription must also be included. For prints and sculptures, the blindstamp or chopmark must be documented and the location described. For three-dimensional works, please provide at least three separate views of the work. 35mm slides, Polaroids, photocopies, and electronic files are NOT acceptable, and your work will not be reviewed if this type of documentation is submitted.
3. You MUST put your name, address and contact information on the back on the sleeve of each Ektachrome transparency that you submit.
4. We also require all available provenance information, copies of all available records of sale, gift or transfer for the work(s), and any other information concerning the work in your possession.

The Keith Haring Studio, LLC will retain all Ektachrome transparencies, provenance, and Certification, Release and Indemnity Agreements for its records. The Keith Haring Studio, LLC reserves the right to reproduce and to use in whole or in part any documentation submitted by you, subject to the maintenance of the confidentiality of your identity, in the event that a catalogue raisonné project is undertaken. Throughout its review process, the Keith Haring Studio, LLC will maintain in strict confidence your identity as well as any other information provided by you and will not disclose your name or such information to any third party without your express written consent.

The Keith Haring Studio, LLC cannot proceed with its consideration of your work until we have received all materials submitted together in one packet.
